Founded in 1998 as a Delaware corporation, Port to Port International is now one of the nation's largest shippers of used vehicles and a growing shipper of new and used construction machinery to Central America.

Since 1998 she has led the expansion of the company through Strategic Planning and Logistics, Management, Sales, Accounting, Vessel Chartering and Development of New Markets.

Port to Port International was recognized in 2007 by ENTREPRENUER MAGAZINE as one of the HOT 500 FASTEST GROWING COMPANIES IN THE UNITED STATES and one of the TOP 100 U.S. TRANSPORTATION COMPANIES in INC. MAGAZINE 5000 for 2008 and 2009. In 2008 the SMALL BUSINESS ADMINISTRATION (SBA) named Port to Port International the TOP EXPORTER IN THE MID-ATLANTIC REGION.

She was also named SUPERSTAR IN BUSINESS in 2003 by the Delaware Chamber of Commerce, and featured in DELAWARE TODAY'S DECEMBER issue as THE TOP WOMEN IN BUSINESS 2007.
